2.0. INTRODUCTION

The Virginia Department of Environmental Quality's (DEQ) Virginia Stormwater Management Program (VSMP) is authorized under Article 2.3 (§ 62.1-44.15:24 et seq.) of Chapter 3.1 of Title 62.1 of the Code of Virginia (Virginia Stormwater Act). Regulatory authority for the VSMP is the responsibility of the Soil and Water Conservation Board (Board).

The State Water Control Board may issue, deny, revoke, terminate, or amend stormwater permits; adopt regulations; approve and periodically review local stormwater management programs; enforce the provisions of this article; and otherwise act to ensure the general health, safety and welfare of the citizens of the Commonwealth as well as protect the quality and quantity of state waters from the potential harm of unmanaged stormwater.

The VSMP permit regulations (9 VAC 25-870-10 et seq.) provide a framework for the administration, implementation and enforcement of the Virginia Stormwater Management Act. The regulations also describe the procedures and requirements to be followed in connection with VSMP permits issued by the Board or its designee pursuant to the Clean Water Act (CWA) and the Virginia Stormwater Management Act.

The regulations provide flexibility for innovative solutions to stormwater management issues. The regulations also establishes the Board's procedures for the authorization of a qualifying local program, Board and department oversight authorities for an authorized qualifying local program, the Board's procedures for utilization by the DCR in administering a local program in localities where no qualifying local program is authorized, and the components of a stormwater management program including but not limited to stormwater management standards.

Unofficial copies of the Virginia Stormwater Act and the VSMP permit regulations are included in the Appendix 2-A and Appendix 2-B, respectively. These are accurate as of the publication date of this Handbook. However, official copies, which will always reflect the most up-to-date versions of the law and regulations, should be obtained from Virginia General Assembly's Legislative Information Service (LIS) Website, as follows:
